Financial Management, People and Engagement (FPE) provides a single interface for Macquarie's businesses across key areas of people, strategy, communications and financial management. Comprising two pillars – Financial Management, and People and Engagement – it is responsible for managing the Group's financial, tax and treasury activities and strategic priorities, fostering our culture through people and community engagement strategies, and engaging with stakeholders to protect and promote Macquarie's reputation globally.

Our teams

Finance and Tax is responsible for the integrity and accuracy of our financial records, ensuring we meet financial, regulatory and tax reporting obligations, manages relationships with revenue authorities worldwide, ensures compliance with taxation legislation, and provides financial management and tax services to Macquarie's businesses.

Group Treasury is responsible for managing and reporting on the Group's funding, capital, balance sheet, structure and liquidity position and ensures Macquarie's businesses have the financial resources they need to meet their ongoing commercial requirements.

Corporate Affairs actively engages with stakeholders to protect and promote Macquarie's reputation and brand globally, articulate the Group's story, support strategic priorities, and build understanding and support from a range of internal and external audiences.

People and Culture supports Macquarie's businesses by attracting, developing, rewarding and retaining the best people, and providing operational support to our global workforce. Engages Macquarie's people through the Macquarie Group Foundation, using their time, skills and financial support to further philanthropic causes.

Data, Technology and Operations retains a critical focus on data and service area financial operations, and on uplifting FPE's technology through a unified approach across all activities.

Non-Financial Risk is responsible for implementing Macquarie's operational risk management framework across FPE by monitoring compliance, developing control standards and assurance, and providing guidance to the CFO in their role as an Accountable Person under the Financial Accountability Regime (FAR) obligations, overseeing control standards and undertaking assurance
